**ORDER**

In view of the pandemic situation arising out of the COVID-19 and in easing the lockdown, the following protocols post relaxation is notified for conduct of shop keepers during the COVID-19 Pandemic :-

**HEALTH PROTOCOL FOR SHOPKEEPERS**

**General protocol for all shopkeepers**

1. All shopkeepers/staff-members will have to compulsorily wear face masks during operation of business / shop. Mask should be worn in a correct manner and not removed while talking.
2. Shopkeepers should compulsorily follow social distancing while conduct of business.
3. Shopkeepers must ensure that customers coming to their shops should wear a face mask and maintain social distancing.

**Additional protocol for shopkeepers of medium- and large-sized standalone shops**

In addition to the general protocol, following are the guidelines for shopkeepers of medium- and large-sized standalone shops:

1. Shopkeepers must provide hand sanitizers at the entrance.
2. Shopkeepers must ensure that there is minimum 1-2 meter distance among customers as well as the staff members inside the shop.
3. Shopkeepers must ensure that not more than 5 persons are inside the shop.
4. For those items that need to be checked before buying, shopkeepers should ensure that customers sanitize their hands before touching them. For example, in case of optical stores, it is advised that frames once tried should be sanitized before they are placed back.
5. Frequent sanitization of the entire shop and especially points that frequently come into contact with humans, for example door handles/knobs, should be ensured.


