Issues highlighted during emergency meeting of State Response Team at the office of Shri. Sampath Kumar, Commissioner & Secretary, Department of Health & Family Welfare

- 1. It was observed that on the first day of the relaxation of lockdown, there was open violation of physical distancing norms, especially at the liquor stores and even inside private vehicles. Violation of physical distancing norms was also noticed at Government offices. It was noted that this might derail the efforts the State's Covid-19 containment strategy. In this regard, it was suggested that the issue will be flagged by the Health Department in the Cabinet meeting through the Office of the Chief Secretary.
- 2. It was also suggested that as Meghalaya prepares itself to allow persons from outside the state to come into the state from May 5th onwards, Dr. Aman Warr stated that protocol needs to come out clearly in the media that it is mandatory for any person coming from outside the State to follow 14 day quarantine along with their family members. In addition to this, the do's and don'ts to be followed by persons coming from outside the state is to be made known through various media platforms.
