2. Minimum Qualifying Criteria for AY 2026-27:

All candidates seeking admission must qualify the National Eligibility cum Entrance Test (NEET-UG) conducted by NTA for the corresponding academic year.

3. Eligibility Criteria for Seats under the State Government Quota Seats:

- i. Candidates must be either Scheduled Tribe or Scheduled Caste (including Other Scheduled Tribes and SC) of Meghalaya, holding a valid certificate issued by the competent authority in the state.

‘or’

a permanent resident of Meghalaya possessing a Permanent Resident Certificate (PRC) for General category issued in accordance with Government of Meghalaya Political Department Letter No. POL.97/74/174 dated 10th July 1983.

The ST/SC/OST eligibility criteria is applicable to Meghalaya candidates who are eligible to claim State Quota seats.			

4. Other Eligibility Criteria:

- i. The age of the candidates shall not be below 17 years on the 31st December of the year in which the admission shall be sought for.
- ii. The candidate should be medically fit and to be certified by a medical board constituted by the Health & Family Welfare Department, Government of Meghalaya.

N.B: Medical assessment of PwBD candidates shall be undertaken only by recognised Medical Assessment Boards notified under the latest NMC regulations.

5. Merely appearing and qualifying in NEET (UG) – 2026 does not confer any right to the candidate for admission to MBBS Course. The selection and admission to MBBS course in any Medical Institution recognised for MBBS Course is subject to fulfilling the admission criteria, eligibility, rank in merit list, medical fitness and such other criteria as may be prescribed by the Government of Meghalaya.

6. All candidates intending to apply for the counselling **MUST COMPLETE THE ONLINE APPLICATION** by submitting the application form through the website: www.meghealth.gov.in

7. Declaration and verification of application details:

- i. All entries in the online application form must be filled in by the candidate with utmost care and diligence. The candidate shall be solely responsible for the correctness and accuracy of all information provided, including academic marks, category status, and enclosures uploaded or submitted.
- ii. Candidates are hereby informed that the information furnished in the application form, including marks obtained in the qualifying examination and supporting documents shall be subject to verification and scrutiny by the concerned authorities.

If, at any stage of the admission process or during the course of study, it is found that any information or document submitted by the candidate is false, fabricated, or incorrect, then:

- a. The admission shall stand cancelled forthwith, irrespective of the stage of the course at that time.
- b. The candidate shall be debarred from seeking admission to any course under the State Government quota for a period of three years;
- c. Appropriate legal and/or criminal proceedings shall be initiated against the candidate and, where applicable, their parents/guardian, for submission of fraudulent documents such as Meghalaya ST/SC/OST and Permanent Resident Certificates.

9. Counselling Procedure :

Counselling for State Quota will be conducted by the Meghalaya State Counselling Authority for Medical Education (MSCAME).

- i. **Online Registration:** Candidates must register online for the Meghalaya MBBS counselling process through the official website of the Health & Family Welfare Department, Government of Meghalaya at www.meghealth.gov.in
- ii. **Seat Allotment:** The seats are allotted based on the candidate's merit (NEET rank) and reservation criteria for State Quota. The seat allotment is done in multiple rounds (as per the detailed scheduled)
- iii. **Document Verification:** Candidates must appear for document verification, where they are required to submit the following original documents:
 - Age Proof Certificate.
 - UG-NEET Score Card (2026) & Admit Card.
 - Domicile certificate/Permanent Resident Certificate (if applicable)
 - Class 10 & 10+2 mark sheets and passing certificates.
 - ST/SC/OST Certificates (if applicable).

NB:

As per MCC Guidelines 2026:

- a) Only candidates opting for Freeze shall physically report to the institution for completion of admission formalities.
- b) Candidates opting for Float shall:
 - retain their allotted seat;
 - remain eligible for upgradation in subsequent counselling rounds;
 - not be required to complete final admission formalities until their allotment becomes final.

11. Method of Fee Payment :

- iii. Check the validity of the Debit card/ Credit card and keep everything ready while logging on to the website for submitting application form. Candidate should enter the information asked for and make payment through the portal.
