1. The retired faculty/doctors at various levels from Private Medical colleges, Institutes of National importance (INIs) and other Govt. Medical Colleges within the country, are eligible to apply as per eligibility criteria specified for each post.
2. Application Form is attached in this advertisement below as Annexure -I. Candidates should send scanned copy of filled up form by affixing self- photograph and attaching required documents in a single PDF File. The self-attested copy of the following documents should be attached with the application form:

Required documents/ certificate mentioned at (a) to (l) shall be verified with original document(s)/ certificate before interview/ before an offer of appointment.

3. These **vacancies are provisional** and may increase or decrease as per the actual requirement for teaching & patient care. The competent authority reserves the right to any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving prior notice amended as per changes in the NMC guidelines from time to time.
4. Experience will be counted as per the requirement of the post, till 30<sup>th</sup> April 2026.
5. All Candidates must have up-dated Medical (NMC/ State Medical Council) with all post MBBS/ MD/ MS Qualification(s). In case, candidate(s) do not have up-dated registration from Medical Council, they have to produce "**Applied for document(s)**" to concerned authority at the time of interview. In case, these two clauses are not fulfilled, the candidate either may not be interviewed or their results will remain with-held, in case the expert

committee allows them to appear for the interview. Even after that, if, candidate is selected, they must have to submit updated Medical Registration Certificate on the time of reporting to join to the Meghalaya Medical Council (MMC).

6. The candidate(s) may ascertain their eligibility and should report for interview on the scheduled date and time for interview.
7. Application should be submitted for each post separately and in the prescribed format only. The application submitted in any other format or incomplete application will be summarily rejected. Wrong declarations/ submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage.
8. Mere submission of application does not confer any right to the candidate to be eligible for interview unless they report on the scheduled date and time for interview with required documents as mentioned.
9. Opportunity of interview given to candidates will be on provisional basis subject to detailed scrutiny of eligibility criteria.
10. The Health & Family Welfare Department reserves the right to cancel/ postpone the recruitment process at any stage at its discretion and such a decision will hinder all concerned.
11. Applicants already employed to Central/ State Govt/Autonomous institutions/ Statutory Organizations/ PSUs under Central/ State Governments should route their applications through proper channel. In case of immediate non- availability of the same, copy of “Applied for NOC” to be submitted at the time of interview.
12. The posts advertised are for full-time and private practice of any kind is strictly prohibited.
13. Candidate(s) will be communicated through email about requirement of any additional documents regarding eligibility & date of interview minimum 07 days before the scheduled date.
14. Age eligibility: Age Limit as on 30.04.2025: not exceeding 70 years of age. The maximum tenure of such engagement will be till 70 years of age or the years of contract as mentioned in ToR whichever is earlier- provided other rules & regulations are satisfied.

#### **15. Selection Procedure:**

- The Selection will be made on the basis of acquired academic credentials and performance of candidate in interview before the Selection Board.
- Result will be displayed in H&FWD website. Offer of Appointment will be sent via E-mail.

Selected candidates will have to join as per instructions mentioned in offer of appointment.

16. The selected candidates will be issued appointment letter. Appointment of selected candidates is subject to:
  - a. His/her being declared medically fit by the Medical Board Constituted.
  - b. Fulfilment of other conditions including verification of the documents, declaration and antecedents of the candidate.

## **Terms of Contract:**

1. The appointment is purely on CONTRACT BASIS for a period of 1-year extendable up to specified number of years as mentioned against each post in the table 1.4 with effect from the date of joining. However, the contractual appointment shall not be extended beyond the Maximum Fixed Tenure of Appointment as mentioned in Table 1.4. If the contract is not extended further, the same will lapse automatically. The appointment can also be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason. This can also be done in case of failure on the part of Contractual Faculty found to be not competent within the period of three months after joining, subject to approval of competent authority.
2. The appointment to the said post will be subject to medical fitness from the competent medical board for which he/she will be sent to the designated Medical Authority.
3. The consolidated remuneration for the post of Professor on Contract Basis will be as mentioned in the table 1.3 above. On appointment, the appointee will be required to take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed Performa.
4. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required related to Tura Medical College. No extra/additional allowances will be admissible in case of such assignment.
5. The appointee shall not be entitled to any benefit like General Provident Fund, Pension & Gratuity, or any other benefits available to the Government Servants, appointed on regular basis. Period of contractual appointment will not be considered for the purpose of seniority or for promotion in case of regular appointment. However, he/she appointed as Associate professor shall be eligible to get designated as Professor with the continued same salaries fixed at the time of appointment with admissible increments as specified after 4 years and 3 years of their tenure at mentioned posts respectively as per NMC TEQ requirement.
6. A fixed-term bond of one year shall be signed with the employee. Early termination of the bond period will not be permitted under normal circumstances and may incur a penalty or fee proportional to the number of months remaining in the bond at the time of termination.
7. The appointee shall not be granted any claim or right for regular appointment to any post of Tura Medical College.
8. The appointee shall be on the whole-time appointment of the Tura Medical College, and shall not accept any other assignment, paid, or otherwise and not engage himself /herself in a private practice of any kind during the period of contract.
9. The appointee is not entitled to any T.A. for attending the interview and joining the appointment.
10. Other conditions of service will be governed by relevant rules and orders issued from time to time in Tura Medical College under Department of Health & Family Welfare Department.
11. If any declaration given or information furnished by him/her proves false or if he/she is found

to have willfully suppressed any material, information, the contractual appointment will be terminated, and any other action as deemed necessary will be taken.

12. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular /permanent faculty members of the Tura Medical College, from time to time.
13. Private practice of any kind including laboratory and consultant practice is prohibited. The contractual Faculty members will not engage himself/ herself in any other paid assignment during period of his contract with Tura Medical College.
14. If at any time in the opinion of competent authority, which is final in this matter, Contractual Faculty is found non performing or guilty of any offence of dishonest, disobedience, disorderly behavior, negligence, indiscipline absence from duty without permission or any other conduct considered by the competent authority, deterrent to the interest of Tura Medical College or violation one or more terms and condition of this letter, his / her services may be terminated without notice and the competent authority shall be entitled to recover any damages arising out of any act of permission on his / her part, from him/ her.
15. Other condition of services will be as provided under the Rules, Bye laws and Regulations of the Institute and governed by the relevant rules and orders issued by the Government of India. It may be noted that the Contractual Faculty member will be required to confirmed to the rules. Bye laws, Regulations, Discipline, and code of conduct prevailing in the Institute.
16. Contractual Faculty members will not have or acquire during validity of this contract either directly or indirectly any outside interest in any business or otherwise, which could conflict with the interest of Institute as a whole or that would be prejudiced to his / her position. Contractual Faculty members will any interest in any commercial concern or company etc. before joining failure to do so well entail termination of his / her contract forthwith without prejudice the right of this Institute for Initiation of legal action against him/ her deemed fit.
17. Contractual Faculty members and his / her members shall not accept any gifts or presentations directly or indirectly. Whether in the form of money, free possession of goods or other benefits from any persons or firm with whom he / she is or likely to be in contract by virtue of this contract with whom his/ her has or is likely to have dealings. His / Her services would be terminated, if found involved in corrupt practices, besides acting as per rules / law.
18. Contractual Faculty members will devote his / her whole time and attention exclusively to the duties entrusted to him/ her to the best of his / her power ability and skill. He / She will acknowledge that his / her position entails absolute confidentially and therefore during the continuation of this contact arrangement and / or after cessation of this contract for any reason whatsoever he/ she will not include or disclose any information papers and documents in his / her knowledge and custody to any outsider and maintain absolute confidentiality.
  - a. The contractual appointees are required to mark attendance manually as well as on Aadhaar Enabled Bio-metric Attendance System (AEBAS) daily during scheduled working days.
  - b. Other terms and conditions will be applicable as issued by Competent Authority from

time to time.

19. The selected candidates shall be required to sign a contract agreement with the employer.
20. In the event of any inconsistency, ambiguity, or dispute, the applicable norms, regulations and guidelines issued by the National Medical Commission under TEQ 2025 shall prevail.
21. The high court of Meghalaya at Shillong shall have the exclusive jurisdiction to try any dispute with regard to this recruitment.
