Online Application in prescribed format for 3 year course in General Nursing & Midwifery (GNM) Training session 2024-25 are hereby invited through online submission from 6th June, 2025 at 10 A.M up to 27th June, 2025 till 3:00 P.M. For details and online submission of form, kindly visit the website www.meghealth.gov.in

- 1. Eligibility: Male/Female candidates who are indigenous inhabitants or permanent residents of the State of Meghalaya are eligible to apply subject to fulfillment of the following criteria:
 - (i) Age: Minimum age for admission will be 17 years as on 31st December 2025. The upper age limit is **35** yrs and for candidate possessing ANM Certificate, there is no age bar.
 - (ii) 10+2 level examination with 40% aggregate marks from recognized University/ Board. Candidates are also eligible from the State open School recognized by State government and National Institute of open School (NIOS) recognized by Central Government. However Science is preferable.
 - (iii) 10+2 with English having 40% of Marks in Vocational Stream-Health Care Science from recognized CBSE Board/ State/ Centre.
 - (iv) Registered Auxiliary Nurse Midwife (ANM) with 10+2 educational qualification.
 - (v) Disabled Candidates 3% disability reservation to be considered with a disability of locomotor to the tune of 40% to 50% of lower extremity after thoroughly examined and certified by Medical & Health Officer.
- 2. Application which does not fulfill the requirement as per INC will be rejected. No application will be accepted or entertained after the last date of submission.
- Candidates are required to appear before the Screening Committee which will be held on the 21st & 22nd July, 2024 from 8:00 A.M 5:00 P.M at School of Nursing Civil Hospital, Shillong and Civil Hospital, Tura. The Applicant will also be medically examined at the same time.
- 4. The list of candidates eligible for appearing the Screening will be displayed in the Government website at www.meghealth.gov.in.
- 5. The applicants are to bring along with all the relevant documents in originals at the time of Screening.
- 6. To minimize the delay and hardship to the candidates, screening will be arranged in order of merit and aggregate percentage of marks obtained at the qualifying examination which will be approximately two/three times the number of seats available category-wise.
- 7. Final Selection of candidates who are medically fit and eligible will be made purely on the basis of merit and subject to reservation policy of the State Government.
- 8. The Final list of selected candidates eligible for the course will be displayed in the Government website at www.meghealth.gov.in. No individual intimation will be served on candidate selected.
- 9. Selected candidates are to report immediately to the O/o the Director of Health Services, Medical Education & Research (DME), Pasteur Hills, Lawmali for accepting the course.
- 10. Selected candidates who fail to report according to the fixed date will automatically lose their right to nomination and the next eligible candidate from the merit list will be nominated.
