CORRIGENDUM

Dated, Shillong, the 5th August, 2026

No. Health.110/2023/90: In partial modification of the Expression of Interest (EOI) No. Health.110/2023/86 dated 23rd July, 2026 for the Operation & Management of a Nursing College with 60 B.Sc. Nursing Intake under a Public Private Partnership (PPP) Model at Umsawli, Shillong, Clause 3.3.23 (Legal Terms & General Conditions Governing the EOI), Sub-Clause (9), shall be substituted and read as follows:

"Sub-Contracting and Consortiums: Unless explicitly permitted by the Authority, sub-contracting of core functions is not allowed. Any consortium arrangements must be disclosed in full at the time of application, with clear role allocation and a lead entity designated.

Consortium shall mean an association of two or more entities that has been duly constituted and registered under the applicable laws for a continuous period of ten (10) years immediately preceding the Bid Due Date and possesses demonstrable experience in undertaking assignments of a similar nature and complexity.

The Consortium shall, along with its Bid, furnish documentary evidence establishing its constitution, registration, continuity of legal existence and relevant experience, including:

- (i) the Consortium Agreement, Joint Venture Agreement, Partnership Deed or any other legally enforceable constitutive instrument, evidencing that the Consortium **has been duly constituted and registered under the applicable laws for a continuous period of ten (10) years** immediately preceding the Bid Due Date, and setting forth the constitution, governance structure, rights, obligations, responsibilities and equity participation, if any, of the constituent members, including the designation and authority of the Lead Member
- (ii) audited financial statements, annual statutory filings, Income Tax Returns, GST registration certificates and GST returns, wherever applicable, of the Consortium or, where the Consortium is not a separate legal entity, of its constituent members, together with such documentary evidence as may establish the **continuous existence and operation** of the Consortium during the aforesaid period;
- (iii) documentary evidence, including work orders, letters of award, agreements, completion certificates, client certificates or similar records, establishing that the constituent members **have jointly undertaken and executed** projects under the said Consortium arrangement; and
- (iv) a duly executed Power of Attorney or Board Resolution authorizing the Lead Member to represent and bind the Consortium for all purposes connected with this EOI.

Failure to furnish the aforesaid documentary evidence shall render the Bid non-responsive and liable to rejection.

All other terms and conditions of the EOI shall remain unchanged. This Corrigendum shall form an integral part of the EOI and shall be read in conjunction with it.
