1. During the period of Study Leave, the Officer shall draw salary equal to the pay without any allowance except DA, as provided under S.R. 103(2)(a) of the Meghalaya FRs & SRs, 1984.
2. The Officer will have to execute a bond, if not executed, that they will come back to serve the State and in case of resignation within 5(five) years after completion of the course, he shall be required to refund the entire expenditure borne by the Government including Salary, T.A/D.A, Fees, etc, for the period during his Study Leave.
3. The Officer shall provide his email ID/Address for communication and shall intimate change, if any in his email ID/address from time to time. The Officer would have continued to hold the post but for his proceeding on leave and there is every likelihood of his/her returning to the same post and place from which he proceeded for the Post Graduate study.
