2	One Mental Health Professional	Post-Graduate degree (Ayurveda) in Mano Vigyan Avum Manas Roga or a post-graduate degree (Homeopathy) in Psychiatry or a post graduate degree (Unani) in Moalijat (Nafasiyatt) or a post- graduate degree (Siddha) in Sirappu Maruthuvam, preferably with atleast 15 years experience
3	One Psychiatric Social Worker	Post Graduate degree in Social Work and a Master of Philosophy in Psychiatric Social Work as maybe prescribed by UGC, preferably with atleast 15 years experience
4	One Clinical Psychologist	Having a recognized qualification in Clinical Psychology from an Institute approved and recognized by Re-habilitation Council of India, preferably with atleast 15 years experience
5	One Mental Health Nurse	Diploma or degree in general nursing or diploma or degree in psychiatric nursing recognised by the INC preferably with atleast 15 years experience
6	Two persons representing persons who have or have had mental illness
7	Two persons representing care-givers or persons with mental illness or organization representing care-givers	Shall be family members residing with and providing care for the/of persons with mental illness or organizations representing care-givers
8	Two persons representing non-governmental organizations which provide services to persons with mental illness	Shall be representatives of registered NGOs, preferably with 10 years experience in Mental Health
