- 3. The Officer(s) shall provide his/her email ID/Address for communication and shall intimate change, if any in his email ID/address from time to time. The Officer(s) would have continued to hold the post but for his/her proceeding on leave and there is every likelihood of his/her returning to the same post and place from which he/she proceeded for the Post Graduate study.
